

METAL AND PLASTIC



PUT:

- drink bottles (crushed PET bottles)
- plastic packaging
- composite packaging (milk boxes, juice boxes - crushed)
- plastic bags and other foils (not dirty)
- drink and food cans
- aluminium foil (not dirty)
- household detergent packaging
- plastic flowerpots

DO NOT PUT:

- non-empty bottles and containers
- medicines and used medical articles
- car parts
- used batteries and accumulators
- used electrical equipment and home appliances
- foamed plastics, rubbers, silicones
- disposable nappies
- sanitary towels
- clothes, leaves

GLASS



PUT:

- empty glass packaging
- bottles, jars, perfume flacons

DO NOT PUT:

- ceramics, flower pots
- tableware, crystal glass
- heat-proof glass
- bulbs and fluorescent lamps
- floodlights
- mirrors
- car and window panes
- thermometers
- broken glass

PAPER



PUT:

- paper and cardboard packaging (folded)
- newspapers, magazines
- catalogues, leaflets
- paper, printed paper sheets
- books and notebooks
- paper bags and sacks
- packing paper

DO NOT PUT:

- dirty, greased, humid or wet paper
- paper that is permanently welded with foil
- composite packaging (e.g. milk or drink boxes)
- disposable nappies and sanitary towels
- used kitchen towels and tissues
- fertilizer, cement or other building material bags made of paper
- wallpapers

BIO



PUT:

- vegetable and fruit wastes (peelings, etc.)
- small branches of trees and shrubs
- mowed grass, leaves, flowers
- sawdust and tree bark
- food remains (without meat)
- egg shells
- coffee and tea grounds

DO NOT PUT:

- bones and meat remains
- foil bags
- animal faeces
- impregnated wood
- chipboards and MDF boards
- stones and ash

PRINCIPLES FOR WASTES SORTING

MIXED MUNICIPAL WASTES



PUT:

- meat remains and bones
- used towels and paper napkins
- dirty plastic bags and foils
- tea bags, coffee filters
- nappies, sanitary towels
- tableware, china

DO NOT PUT:

- medicines that are past their sell-by date
- used batteries and accumulators
- radio and TV equipment and home appliances
- bulbs, fluorescent lamps
- building and demolition wastes
- large-sized wastes
- clothes and textiles

While sorting the wastes, absolutely take care of:

DANGEROUS WASTES, which include:

- used batteries, accumulators
- medicines that are past their sell-by date
- used fluorescent lamps
- wastes coming from caustic chemical substances

ELECTRICAL EQUIPMENT, which includes:

- radio and TV equipment and home appliances
- mobile phones, hardware
- electrical and electronic toys

OTHER WASTES, like:

- bulky waste
- clothes and textiles
- building and demolition wastes

Such wastes must not be put into municipal waste containers, they may be left free of charge in the specially designated places:

- shops and pharmacies
- Municipal Waste Selection Points (PSZOK).
